IMC (India Mobile Congress) Awards, 2019

Definitions:

- 1. Awards IMC Awards 2019
- 2. Awards Management Organizers of the awards, IMC
- 3. **Participant –** Any Indian organization sending an application to participate in the Awards, or is selected for participation in the Awards upon recommendation/ suggestion received from the Members of the Award Management or third parties by submitting a nomination form.
- 4. **Jury** A constituted panel of eminent experts from the relevant industry who will shortlist the winners for specified award categories as mentioned below.
- 5. Winner Any participant selected by the Jury as per pre-determined evaluation parameters
- 6. Knowledge Partners for IMC 2019 KPMG (Registered)

Categories

Entries are open for participation in the following categories:

- 1. State with best 4G/ Broadband network coverage*: The entrant state(s) must have network service providers within the state in whole of India. The service providers must have all the necessary documentations as prescribed by the law, must contain a minimum average speed of 8.00-23.1 mbps (download).
- * Open signal testing would also be one of the parameters utilized for evaluation
- **2. Smart Cities Project with most innovative technology adoption:** The entrant Smart City must include state of the art technologies for the dedicated segment/whole of the project. The project must have received their OC before the 31st of December, 2018.
- **3. Best Mobile Innovation for Automotive:** The entrant participant must be providing services for over a period of 1 year as on the 31st of March,2019. The participant must have all the necessary documentations prescribed by the law, must contain a new innovation for the automotive industry.

- 4. **Most Innovative IoT Project:** The entrant participant must have engineered an innovative product, service or solution that solves a problem with a simple fix, and should result in making life easier. The developer must have tested the market with his product for a period of 1 year as on the 31st March,2019.
- 5. **Best Mobile Innovation for Health**: The entrant participant must have engineered a product/application or a service which provides a positive contribution in the area of human health and is within the legal mandates. The innovation must have been done before the 31st of March,2019 and such innovation must have taken place with all the necessary documentations required by law.
- **6. Best open source solution for telecom industry:** The entrant participant must be providing the service for a period of over 1 year as on the 31st of March, 2019. The solution is preferred to be cloud, network functions virtualization (NFV) and software-defined networking (SDN) or any solution implemented and tested in a telecom Network based and entrant should contain all the required documentations required by law.
- **7. Most innovative use of block chain across industry:** The entrant participant must have streamlined internal processes, roaming, smart connection, smart transactions, mobile money, identity management etc. with their innovation. The participant must have developed and tested the market with his innovation over a period of 1 year as on the 31st of March 2019, should also contain all the necessary documentations required by law.
- **8. Most Innovative App:** The entrant participant must have developed his application over a period of 1 year as on the 31st of March 2019. The application should be an innovative framework of services that application programs rely on for standard operations. The same should be available on all mobile platforms namely Play store, App Store, etc. and should contain all the necessary documentations as required by law.
- **9. Most Innovative Approach to Network Security:** The entrant participant must have developed an application and/ or a solution which provides an innovative touch to network security, it should have tested the market and should be providing the same for a period of over a year as on the 31st of March,2019. The participant must have the necessary documentations required by law.
- **10. Most Innovative Network Transformation Initiative:** The entrant participant must have structured an initiative in the form of a product, service or a solution which is such that it either bridges gaps on innovation, it enhances customer engagements or creates self-optimizing and secure zero touch networks.
- **11. Dynamic telecom product/ solution of the year:** The participant needs to have developed a product/ solution which has enabled telecom industry drive efficiencies as well as contributed towards cost savings

Eligibility criteria:

IMC Awards invites organizations in India to send their entries. The following eligibility criteria apply to all Awards categories:

- 1. The entrant organization must be a registered business organization as on 31st March, 2019.
- 2. The entrant participant must be complaint with the Indian laws as may be applicable to the participant category. Any violation found subsequently would result in notification to the participant and possible disqualification in case the reply to the notification is not received or is not satisfactory.
- 3. The entrant participant must hold all the required licenses and other statutory requirements as applicable to the applicant category. Any violation found subsequently would result in notification

to the participant and possible disqualification in case the reply to the notification is not received or is not satisfactory.

- 4. Though not a binding requirement, it would be preferred that the entrant participants have a patent or a patent application (local or global) for the category as applicable.
- 5. Though not a binding requirement, the entrant participants would be preferred to hold a technology license or a trademark and franchising license as applicable.
- 6. Telecom operators are not explicitly not permitted to submit entries for awards
- 7. The minimum investment done by the organization must be INR 10 Lakhs.
- 8. The following eligibility criteria are specific to the categories mentioned below:

Call for entries and participation

- 1. Last date for submission of entry forms will be **September 15th**, **2019**;
- 2. Categorization of entries will be approved by the Jury/ Awards Management. The Jury/ Awards Management retain discretionary right to re-categorize an entry, if needed;
- 3. Participant that conforms to each of the Award categories can participate in the same entry which is not attributable to the listed categories would automatically stand disqualified. Determination of the same is at the discretion of the Jury/ Awards Management;
- 4. A participant can participate in multiple Award categories for the same services;
- 5. One application form can be used only for a single entry in each award category;
- **6.** Receipt of application forms after the specified last date of receipt may be permitted only for genuine reason at the discretion of the Awards Management/ Jury:
- 7. Awards Management will not be responsible for application forms that are lost in transit/ received late/damaged/ loss due to lack/ lapse in any communication on account of internet failure;
- **8.** Participation in the Awards in any manner will be construed as an acceptance to the Rules and Regulations stated herein;

- 2. Entries will be accepted in English language only.
- 3. Disgualification of any entries is at the sole discretion of the Awards Management.
- 4. Please maintain one copy of the completed form with you for your records
- 5. Absence of a nominee or representative of the Participant at the final Jury meeting will automatically lead to disqualification of that particular entry.
- 6. If at any time, during the Awards process or post the Awards ceremony any information provided by any Participant is found to be incorrect in any manner, then the Participant will be either disqualified from participation or liable to return the award and any monetary/ non-monetary incentives provided as part of the Award, if won.
 - a) If at any time, any information provided by any Participant is found to be incorrect in any manner, then the Participant will not be permitted to continue participation for that particular entry in the Awards, and the Awards Management will not be liable to return any materials to such disqualified entry.
 - b) If, after the conclusion of the Awards ceremony, any information provided by any Participant is found to be incorrect in any manner, the Participant will be liable to return the Award and any monetary/ non-monetary incentives provided as part of the Award,

- 11. Awards Management or team appointed by Awards Management will try to contact the Participant on best effort basis by any means deemed appropriate.

 - b) Jury will select the winners in each category based on predetermined judging parameters by scoring the entries,
 - c) The determination of who should receive an award for any award category rests with the Jury,
 - d) The Award Management's decision is final and binding on all nominees.
- 14. Only CEO or heads of participant Enterprise would be contacted in case, Jury needs further information. The cost of travel incurred by participants, if any, would need to be borne by the participant.

- 15. Participant agrees that the Participant is legally capable of entering and, if selected, participating in the Awards and agree to the Terms. Participant is competent (i.e. Participant are of legal age and mental capacity) and eligible to enter into this legally binding agreement on Participant.
